- 3. Coaches will set out cones to designate where players place their individual items to maintain 6 foot social distancing during water breaks.
- 4. Coaches have their plans in place and will ensure players are maintaining their distance and wearing their masks during practice.
- 5. Start date of September 14th approved and board and coaches in agreement to.
- 6. Discussed adding 2nd graders. Coaches in favor.

D. Equipment:

- 1. Traffic signs Robyn already purchased.
- 2. Electronic whistles so coaches do not need to uncover their mouths to use Robyn to order 2 & Whitney to order 2 from Amazon (2 per person limit).
- 3. Infared thermometer for touchless player temp checks Robyn already purchased.
- 4. Additional flat orange cones for player belongings, clip boards & enough hand sanitizer for before, during and after practice use by board, coaches & players Robyn & Jess to make a trip to pick up essential items.
- 5. Flag football gear to be ordered as we get closer to that portion of the session.

E. Required Paperwork:

- 1. As outlined in our proposal we will require the following paperwork: (attached to these minutes)
 - Completed registration
 - COVID Liability Waiver
 - Emergency Contact Information form
 - Physical on file from last year for returning players or completed current physical for new players.
- 2. Players will not be able to practice until all paperwork is received.

Skills and Drills Program

York Youth Football is seeking approval to hold a 6 -week skills and drills session potentially beginning the week of August 24, 2020 through October 5, 2020. Each week we will be evaluating the latest State and local guidelines and will work toward the re-introduction of contact football if possible. By implementing a 6 -week tiered session, we will be getting our players ready for tackle play when/if it becomes an option.

York Youth Football proposes to use the upper football field at the Bog Road Athletic Fields on:

- Mondays and Wednesdays from 5:30-7pm for 3rd, 4th and 5th graders
- Tuesdays and Thursdays from 5:30-7pm for 6th, 7th and 8th graders
- The total number of players, coaches/board members will not exceed the current State of Maine guidelines for organized group gatherings.
- Parents will drop-off and pick-up only and will not be allowed to attend practice sessions.

The session will be broken out into 2 weeks each in order of:

- Conditioning
- Fundamentals
- Work on plays including flag football

Session timeline:

- Drop off runs from 5:15-5:25
- Participant drop-off line will be at the end of the dirt road leading from the parking lot to the field.
- Parents should enter the upper parking lot area and pull up to the dirt road. A "stop" sign will be displayed where parents should stop. Cones will be used to direct the flow of traffic out of the parking lot by going around the lined parking spots. A "do not enter" sign will be place where vehicles are to be exiting to discourage parents from leaving the flow of traffic. We will use volunteers to assist in the traffic flow whenever possible in addition to the cones and signs.
- Parent/guardian and player should wait in their vehicle, with masks on, until a coach or board member walks to greet them.
- Coach or board member will wear a mask to complete a wellness check on the camper with a series of questions. Parent/guardian must stay in their vehicle. If your player does not feel well, please do not come to camp. The screening questions and response are as follows:
 - Do you have:
 - o Fever or chills
 - Cough
 - Shortness of breath or difficulty breathing
 - Fatigue
 - Muscle or body aches
 - o Headache
 - New loss of taste or smell
 - Sore throat
 - Congestion or runny nose
 - Nausea or vomiting

Diarrhea

And

- Have you had any contact with a confirmed or probable case of COVID 19 or person who has had any of the previously mentioned symptoms in the past 14 days?
- If participant answers yes to any of the questions, participant will be asked to leave and monitor their symptoms.
- If player answers no, they will exit the vehicle wearing a face covering, coach or board member will give the player a pump of hand sanitizer and be directed to the field entrance at the end of the field. Their attendance will be recorded for COVID tracing.
- Players will be expected to maintain social distance from other players while awaiting instruction.
- Once on the field participants will place their items in their own designated area and proceed to their designated area on the field.
- Coaches will keep participants in their designated area on the field for stationary drills where they will be able to remove their face covering. There will be markers on the field to show players where to stand to maintain at least a 6 foot distance from each other.
- Ball work, passing & moving drills will be done in groups of no more than 10 participants. The ball will be wiped/sanitized after each drill/skill set as well as before and after practice.
- The groups of 10 will be spaced as far apart on the field as possible and be in groups based on positioning. Coaches for those positions will stay with the corresponding group of players. For moving drills (such as running laps, sprints, routes, etc.) participants will be expected to maintain a 6 foot distance from each other with coaches closely monitoring the spacing.
- During flag football play participants will wear their face coverings. Flags/belts will be collected after each practice by a coach or board member to be sanitized before and after every practice.
- At the end of each practice participants will wear their face coverings to collect their things, be given hand sanitizer to use on their way off of the field & find their parent waiting in the car in the upper parking lot.

Pick up:

- Pick up runs from 7-7:10p
- Parent/guardian will park in the upper parking lot and wait for their player to come out to their vehicle. Parents should not exit their vehicle.
- Players will hand sanitize after practice and before entering their vehicle.

What to expect:

- Players will be required to have a face covering at each practice.
- We are asking each player to bring their own bottle of hand sanitizer for personal use, making sure that it contains 60% or more of alcohol and that it is not on the recall/unsafe list.
- Players will be required to have their own water bottles with plenty of water.
- Players are expected to be mindful and maintain social distancing while on the field at practice.
- Players will wash or sanitize their hands upon arriving to the field, during, and upon leaving practice. Players will be asked to sanitize after every activity.
- Players will wear a face covering throughout practice unless they are engaging in activities that involve lots of movement and socially distancing can be maintained.

- All equipment used during practice will be cleaned/sanitized before, during and after use.
- If your player is feeling ill during practice, the parent/guardian will be notified and expected to pick up their player as soon as possible. The player will be isolated from the cohort while awaiting parent/guardian pick up. If a case of COVID-19 is confirmed in either a coach/board member or a player, we will notify parents immediately and practice will be discontinued for a minimum of 48 hours. A local health officer and the Maine CDC will be notified, and YYF will adhere to their recommendations. A coach/board member or player who has been exposed to an individual with COVID-19 must quarantine for 14 days, have a doctor's note and documentation of a negative test result in order to return to the field.

Required forms:

- In order to participate a returning player must have a signed physical on file from last year; new players must bring a signed physical. Forms can be found at yorkyouthfootball.com.
- Players must have the signed COVID liability waiver before participation.
- The emergency contact form must be filled out before participation.
- Required forms can be brought to the first practice at drop off. Players without all paperwork on file will not be allowed on the field.

We will base our program on the guidelines outlined by USA Football and the State of Maine Youth Sports Industry Guidelines which include:

- Maintaining a 6 foot distance between all players and coaches when not directly participating in practices and games.
- No more than the maximum number of people allowed, per the Governor's executive order for outside group gatherings.
- Players will wear cloth face coverings when not engaged in physical activity.

Other guidelines include:

- Participants will bring their own water bottle no sharing of water bottles or other personal equipment or belongings will be allowed.
- Disinfectants and hand sanitizer will be available on site and used regularly.
- Coaches will always wear their face coverings.
